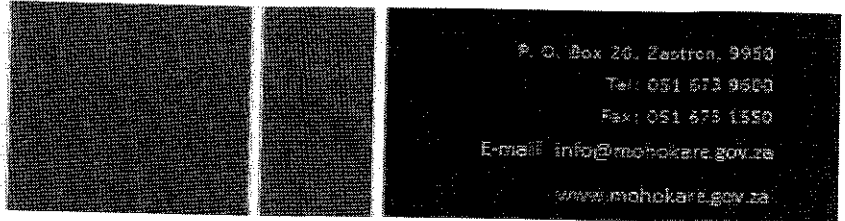

 - (ii) invite the local community to submit representation in connection with the annual report.




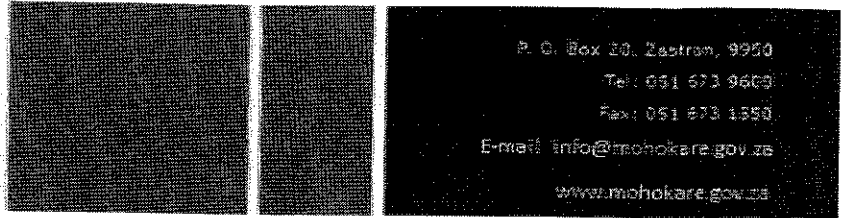

MID-YEAR REPORT

Local Government Municipal Finance Management Act, 56 of 2003 states: Municipal Budget and Reporting Regulations states: **Section 34**


1. Within five working days of the 25 January each year the municipal manager must make the mid-year Budget and performance assessment public by placing it on the municipal website.
2. The municipal manager must make public any other information that the municipal council considers Appropriate to facilitate public awareness of the mid-year budget and performance assessment including-
 - (a) summaries in alternate languages predominant in the community; and
 - (b) information relevant to each ward in the municipality.


