Mohokare Local Municipality hereby invites all suitable and competent contractors to submit bids for the construction of paved access collectors, internal streets and related storm water in Smithfield / Mofulatshepe, for a length of 5km.

Tenderers should have a CIDB grading of 6CE PE or 7CE or higher. Regulation 25(8) of the CIDB regulations will apply for Potentially Emerging (PE) contractors who satisfy the criteria stated in the Tender Data.

Tenders shall be evaluated using the functionality criteria comprising of the following:

The 90/10 (Price 90 & B-BBEE status level of contribution 10) Preference point system will be used.
