1.8 **“B-BBEE status level of contribution”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment Act;

1.9 **“Bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods, work or services.

1.10 **“Comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilised have been taken into consideration

1.11 **“Consortium or joint venture”** means as association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract.

## **PANEL OF ICT SERVICE PROVIDERS FOR 3 YEARS**

### **SCOPE OF WORKS**

The Municipality is looking for a panel of ICT service providers to maintain and repair servers, printers, desktops, switches, storage devices, laptops in Mohokare Local Municipality offices for a period of 3 three (3) years.

#### **Background**

Mohokare Local Municipality purchased a fleet of laptops, desktops and printers that are being utilized in all MLM offices. ICT equipment/devices are electronic therefore, it's natural that these devices can fail. It is ICT's Responsibility to make sure that the equipment is serviced and we have a backup plan should the equipment (e.g. Servers and Computers) fail as these have to be up and running 24 hours a day. To mitigate this risk, it is strongly recommended as the best practice to have a second line ICT maintenance support to assist the municipality when maintenance is beyond their internal capacity.








Currently there is no service level agreement in place for periodic maintenance and repairs of ICT Equipment as and when required. MLM business is interrupted due to breakdowns that occurs and the turn-around time to resolve problems takes too long because of the lengthy Supply Chain Management (SCM) processes that have to be followed to acquire the aforementioned services.


