SCOPE OF WORKS

Background

Mohokare Local Municipality, in the course of executing its duties and fulfilling its legislative mandate makes use of travel, accommodation and conference facilities. The abovementioned services are utilised by council and officials of Municipality.

Travel services required include air travel, hotel accommodation, conference facilities, airport transfers, point to point shuttle services and car rentals through the appointed service provider.

Objectives

Provide Mohokare Local Municipality with consistent and reliable travel management services and will maintain a high level of Municipality satisfaction in line with the service levels.

To appoint at least three service providers for a period of 36 months

Scope of the required service

The successful bidder/s shall be required to provide the following:

- 1. Provide travel management services during normal office hours Monday to Friday 08h00 to 17h00 (South African Standard Time).
- 2. Provide a consultant or team of consultants to assist Municipality with after hours and emergency reservations and changes to travel plans.
- 3. Provide a dedicated consultant/s to assist Municipality with after hours and emergency assistance.
- 4. Provide after hours' services from Monday to Friday outside the official hours (08h00 to 17h00) and twenty-four (24) hours, including weekends and Public Holidays.
