SCOPE OF WORKS

BACKROUND

Medical surveillance means a planned programme of periodic examination of employees by an Occupational Health Practitioner or by Occupational Medicine Practitioner. This process must be done on an annually basis.

In terms of Occupational Health and Safety Act, Act 85 of 1993 and Regulations for Hazardous Biological Agents (HBA 8 (i)) and Chemical Substances; an employer shall ensure that the employees working at risk undergo medical surveillance to protect employees from hazards at work (protection and prevention principle). It is under this background that Mohokare Local Municipality is embarking to perform Medical Surveillance for its employees.

The Act state that all employees must undergo a medical checkup for occupational health and diseases once in a year.

The vaccinations for Hepatitis A & B must be administered at examinations, a booster after 6 weeks and again after 6 months for all exposed employees.

QUALIFICATION AND EXPERIENCE

The service provider must meet all Medical Requirements. His/her qualification as a medical doctor (MBCHB) should be valid and comply with the requirements set out by South African Medical Council.

- Must hold a valid qualification on Occupational Health and Clinical Primary Health Practitioner or
- Must hold a B-Tech Occupational Nursing
- Must have valid certificate of practice with Health Professional Council of South Africa.
- A valid Calibration certificate for Instruments and testing machines.

Must have relevant experience as an Occupational Health and Safety Medical Practitioner or Primary Health Care.

SCOPE OF WORK

Service provider must have own mobile clinic to perform work and must be able to move within Mohokare Units, which is Zastron Unit, Rouxville Unit and Smithfield Unit.

Service provider will perform the Occupational Medical Surveillance to 150 Mohokare General Workers from the 3 units, Smithfield, Rouxville and Zastron, which comprises of the following:
