- VAT Registration (if applicable);
- B-BBEE Certificate or Affidavit;
- Confirmation of Bank Letter
- COIDA – Letter of Good Standing
- Company Registration Documents; (not older than 3 months)
- Directors Identity Documents; (not older than 3 months)
- Local address within the Mohokare area.

Note that, the promotion of local subcontracting will be prioritised.
